

# MESSAGE FROM THE CHAIRMAN

Greetings ICAP Members,

In 2014, the ICAP Board of Directors conducted a comprehensive two-day strategic planning session, which led to new coverages and programs being introduced that year. And just when we thought we did all there was to be done, we ended up doing a lot more in 2015! Here are some highlights of what we worked on in 2015 to provide even more resources and programs to our members:

#### Comprehensive Cyber Resource Portal

ICAP has introduced, over the last several years, new and enhanced cyber-related coverages to stay ahead of this emerging exposure. With broad cyber coverages firmly in place, the Board turned its attention to securing a comprehensive cyber security and data breach resource for its members. In 2015 alone, the Identity Theft Resource Center estimated more than 781 breaches occurred exposing more than 169 million records. Thus, ICAP partnered with a cyber expert to launch the eRiskHub® at <a href="eriskhub.com/icap">eriskhub.com/icap</a>, a portal that provides ICAP members with an array of cyber risk management resources and tools, including risk assessments, state breach law summaries and guides, cloud risk management resources, data protection and breach readiness guides, sample policies on acceptable use, antivirus and malware, and sensitive information handling. Importantly, the Hub provides contact information for a Breach Coach, who will provide ICAP members with a free initial consultation regarding the steps to take following a data breach and assist members in assembling a team to contain the breach and draft notifications in compliance with data breach notification laws.

#### **Educational Summit**

Hand-in-hand with the launch of the cyber resource portal, ICAP sponsored the 2015 Smart Connections Conference. The one-day conference was hosted in April 2015 as a collaboration among the Iowa State Association of Counties, the Iowa League of Cities and the County Strategic Technology Advisory Resource. The event educated local government officials on select cyber risks and informed attendees of ways to be more secure using email, mobile devices and more. The conference attracted nearly 150 local officials who had the opportunity to hear from a former computer crime investigator for the FBI's Cyber Crimes Task Force.

#### **Property Valuations**

What can at times be as difficult as navigating the cyber world is obtaining current valuations on hard-to-value properties such as historical buildings and water and wastewater treatment plants. To assist our members with this task, we introduced a property valuation program wherein ICAP partnered with an expert professional appraisal company to offer members comprehensive appraisals of their historical buildings, water plants, wastewater treatment plants and buildings valued at more than \$200,000. This program helps members identify and value their properties and structures and has been very well received by the membership.

### Water and Wastewater Operators Continuing Education Credits

In addition to assisting members with valuing water and wastewater treatment plants, we also introduced a program to help the operators too. In 2015, ICAP offered 14 courses approved by the Iowa Department of Natural Resources for continuing education credits for water and wastewater operators, allowing ICAP members to get the training they need – anytime, anywhere, at no cost to the member. These courses can be accessed through ICAP's online resource eLibrary.

#### Back To School

Another 2015 addition to ICAP's online resource eLibrary was Public Entity University (PEU). PEU provides 300 interactive online training courses conveniently organized into various "workplace colleges" including Employment Liability, Streets and Roads, Internet Security/Social Media, Fire and Health Departments, Law Enforcement and General Safety, among others. ### Fair Price and Returns of Member Equity

ICAP has stayed true to its commitment to provide members with broad coverage at a fair price - year in and year out. In addition to a fair price, ICAP members also benefit from distributions. In accordance with its surplus management and distribution policies, the ICAP Board conducts an annual review of operations to determine whether a distribution is in order. The Board declared a 2015 casualty distribution in the amount of \$2,500,000 and a property distribution in the amount of \$500,000. By carefully managing the financial aspects of the program, ICAP is able to both return a portion of surplus to its members today and retain surplus to meet the coverage and service needs of tomorrow.

### Strong Financial Health

As you will see in the financial pages of this report, ICAP had another great year financially and closed out 2015 with a total fund balance of \$51,423,505 up from \$49,893,845 in 2014. We have you, our members, to thank for ICAP's success.

On behalf of the Board, I extend a sincere note of appreciation for your membership in ICAP. In planning for tomorrow, we will continue to be on the leading edge as, together, we make ICAP the premier local government risk sharing pool in the country.

#### CYBER RESOURCE PORTAL



Importantly, the portal provides members access to a "Breach Coach" who will consult and coordinate with other expert vendors in responding to a data breach, which may involve working with computer forensic specialists to contain the breach and secure systems, drafting notifications in compliance with breach notification laws and facilitating the credit monitoring process.

# **INVESTMENTS**

During the year ended December 31, 2015, the Pool experienced net investment losses totaling \$739,729 compared to net investment earnings of \$2,505,021 during the year ended December 31, 2014. Growth in Membership, however, more than offset the net losses on investments. Of the 2015 and 2014 net investment losses and earnings, (\$1,730,714) and \$1,445,873, respectively, consisted of realized and unrealized (losses) gains.

The Pool's policy of structuring the investment portfolio so that securities mature to meet cash requirements of ongoing operations minimizes the need to sell securities in a volatile market. The Pool maintains a well-diversified investment portfolio, as detailed below (percentages are as of December 31, 2015):

## **EVALUATION & OVERSIGHT**

ICAP works with three organizations to obtain independent review, analysis and audit of its financial operations.


Plante Moran, PLLC audits the financial statements of the Pool, which includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements, assessing the accounting principles used and significant estimates made, as well as evaluating the overall basic financial statement presentation. In 2015, Plante Moran issued an unmodified opinion, which means that ICAP's basic financial statements present fairly, in all material respects, the financial position of the Pool at December 31, 2014 and 2015, in conformity with generally accepted accounting principles. An independent auditor conducts an audit of the financial statements on an annual basis.

**Demotech, Inc.,** a financial analysis firm with over 25 years of experience in providing independent opinions on the financial stability of property and casualty insurance companies, title underwriters and government risk pools, conducts an analysis in four key areas: financial stability, loss reserves, administration and overall performance. In 2015, Demotech issued ICAP the highest rating of AAA (unsurpassed) in each area.

The Government Finance Officers Association (GFOA) awarded ICAP a Certificate of Achievement for Excellence in Financial Reporting for the Fiscal Year Ended December 31, 2014. This Certificate signifies that ICAP has excelled in explaining the financial information and all of the supporting data that goes with the numbers. ICAP has earned this Certificate of Achievement for 20 consecutive years.

#### Reinsurance

Adequate and appropriate reinsurance is essential to protect the financial integrity of a group self-insurance program. ICAP is a member of a reinsurance risk sharing arrangement known as American Public Entity Excess Pool (APEEP). This reinsurance arrangement is composed of public entity pools that mirror ICAP in their operation and as such, ICAP members benefit from the advantages of pooling at both the primary and reinsurance levels. ICAP, through its administrator and APEEP, works with reinsurers to make individual arrangements for members that require excess limits. Casualty claims are reinsured through APEEP, General Reinsurance and Argonaut Insurance. Property and vehicle losses are reinsured through APEEP and Lexington Insurance.
